

Minute 20/11/29/09	Minutes 9.1 through to 9.7 are the same as last meeting but are repeated here because the situations reported remain as bad as ever or are getting worse
	9.1) There has been a huge increase in the parking and disruption caused by visitors to the area. Roads are being blocked creating delays for emergency vehicles.
	9.2) Councillors have CCTV footage showing thoughtless parking and resulting congestion
	9.3) Residents are having to change plans and lifestyle to get around congestion. Scouts cannot open.
	9.4) PCSO will support application for local parking restrictions.
	9.5) Drug taking by visitors is becoming a problem activity.
	9.6) Car park at Lud's Church is usually full before 9:00 am. All other visitors parking everywhere and blocking narrow roads.
	9.7) Meeting proposes to arrange meeting with stakeholders including SWT, SCC Highways, Police and Peak Park .
	Furthermore Councillors wish to note;
	9.8) The number of visitors and associated problems is not reducing in bad weather. On 29 th November 2020 there were three gridlock situations at Gradbach caused by visitor parking.
	9.9) The roadside verges are collapsing and being eroded away under the repeated parking by visitors. In some places so much soil has gone that the drystone walls are near collapse and hedgerow roots are being exposed/destroyed. The situation is now causing Permanent Damage to the environment.
	9.10) A Parish Councillor, resident at Gradbach, is fighting a rearguard action against this onslaught by fitting anti-parking posts and reflective tape to try to prevent parking in the worst affected areas but the number of visitors is overwhelming
	9.11) This parking will not only block emergency vehicles, which it has already has but will block gritting vehicles too as the bad weather requires them to work.
